2. Each application shall be accompanied by a non-refundable registration fee, which includes the following: \$100.00 BOOK FEE and a \$100.00 ACTIVITY FEE. Payments of this registration fee will hold a seat for your child. Re-enrolling students are requested to register on or before April 8, 2008. New applicants will be processed beginning April 12, 2008, Open House.
